Henry Cravey gave a prayer. All pledged allegiance to the flag of the United States of America.

Chairman Colson called the meeting to order and welcomed everyone.

**MINUTES:** Henry Cravey motioned to approve the minutes of the January 7, 2013 Organizational Meeting. Ken Hardy seconded, motion passed by yes vote by Chairman James Colson, Ken Hardy, Shelly Berryhill, Henry Cravey and Phil NeSmith. No oppositions or abstains.

**MINUTES:** Phil NeSmith motioned to approve the minutes of the January 7, 2013 Regular Meeting. Shelly Berryhill seconded, motion passed by yes vote by Chairman James Colson, Ken Hardy, Shelly Berryhill, Henry Cravey and Phil NeSmith. No oppositions or abstains.

**MINUTES:** Shelly Berryhill motioned to approve the minutes of the January 14, 2013 Called Meeting. Ken Hardy seconded, motion passed by yes vote by Chairman James Colson, Ken Hardy, Shelly Berryhill, Henry Cravey and Phil NeSmith. No oppositions or abstains.

AGREEMENT WITH JOINTLY OWNED NATURAL GAS: Phil NeSmith motioned to approve the Management Agreement between the City of Hawkinsville and Jointly Owned Natural Gas to manage and operate the City's natural gas system while the City retains ownership. Henry Cravey seconded, motion passed by yes vote by Chairman James Colson, Ken Hardy, Shelly Berryhill, Henry Cravey and Phil NeSmith. No oppositions or abstains.

COMPENSATION INCREASE FOR ELECTED OFFICIALS: Phil NeSmith motioned to approve an increase in the monthly compensation and to run advertisement of same in the local newspaper for three (3) weeks. This will be presented for approval at the March 2013 Regular Meeting. The increase would be \$450.00 per month per Commissioner with the Chairman at \$500.00 per month. Shelly Berryhill seconded, motion passed by yes vote by Chairman James Colson, Ken Hardy, Shelly Berryhill, Henry Cravey and Phil NeSmith. No oppositions or abstains. Murkerson explained that should the increase be approved it will take effect on January 1, 2014.

**REVISION OF PERSONNEL POLICY:** Phil NeSmith motioned to approve recommendation of City Manager for a revision of the Personnel Policy. Shelly Berryhill seconded motion passed by yes vote by Chairman James Colson, Ken Hardy, Shelly Berryhill, Henry Cravey and Phil NeSmith. No oppositions or abstains. The revision reads: If an employee is out of work they will not be paid holiday pay if they have exhausted all their annual and sick leave. Annual or sick leave must be carried over from a prior pay period in order for the employee to be compensated for holiday pay in the current pay period.

HAWKINSVILLE HISTORIC PRESERVATION COMMISSION POST 5: Phil NeSmith motioned to appoint Clay Hall to fill the unexpired term of Post 5. James Colson seconded, motion passed by yes vote by Chairman James Colson, Ken Hardy, Shelly Berryhill, Henry Cravey and Phil NeSmith. No oppositions or abstains. Larry Hedden chose not to continue serving his term. The term will expire November 1, 2013. It is a three (3) year term.

## **CITY MANAGER'S UPDATES:**

I have included a summary report about dilapidated housing and unclean lots from Codes Enforcement. There is a new one in progress by owner at 10 Jelks Street.

I have included a work order synopsis for the month of January from our customer service system. These are completed work orders only.

I have also included an arrears report listing commercial customers who are behind on their bills

City staff, Harp & Associates staff and JONG staff have submitted our response to answer the PSC inspection report. I distributed copies of our response to you via email for your perusal. Our relationship with JONG has been solidified with the agreement you have approved tonight and everything is going really good on our Natural Gas system.

I have been in contact with Ms. Connie Bryant at Middle Georgia Community Mental Health Center and her supervisors have come to Hawkinsville and viewed the available expansion units. They have indicated they would like to move forward with this process. We will continue to work closely with them to address their issues.

The government consolidation documents have been submitted to our Legislative delegation for action and I have forwarded additional documents to Legislative Counsel as they requested. The process seems to be progressing without issues. After we have the local legislation we should then submit to the United States Department of Justice for their review.

I have also submitted the resolution for a Hotel/Motel tax increase from 5% to 8% and the legal notice, as required by Legislative Counsel, will run in the newspaper for three weeks.

Commissioner Shelly Berryhill is the incoming President of GMA District 6 and it is time for nominations to be forwarded to GMA for the upcoming year.

Attorney David Walker talked to Commissioners about the request from Olin McLeod to have a lien released on property on Second Street that he was named an heir to. McLeod claims he is not an heir Walker stated that Johnson Hall had composed a quit claim deed for McLeod. He would talk with Attorney Hall again concerning this matter.

Walker was concerned that JONG did not specify liability insurance in the contract between the City and JONG.

Manager Murkerson stated a letter had been sent to James Laidler explaining per EMA Director/Fire Chief Leslie Sewell's recommendation that Sioux Alley would not be changed because there is already a Laidler Road in the county.

Manager Murkerson stated that Rachel Pitts had called and recommended Lorraine Holmes fill the Post on the Hawkinsville Housing Authority held by Earnestine Anderson, who has chosen not serve any longer. Murkerson was concerned that Ms. Holmes did not live in the city limits. Phil NeSmith asked Chairman James Colson to see if he could find a good candidate to represent the City on the Housing Board.

Ken Hardy shared his concerns about the Pulaski County Sheriff Officers carrying their children in the patrol vehicles.

Commissioners discussed that when they agreed to pay the Pulaski County Sheriff for law enforcement protection 40% of the budget, the lack of traffic citations not going to the Municipal Court was not a part of the deal.

They discussed the possibility of ticket cameras.

Commissioners asked Manager Murkerson to provide them a monthly non revenue water leak report.

There being no further business.
