I have included a work order synopsis for the month of April from our customer service system. These are completed work orders only.

I have also included an arrears report listing commercial customers who are behind on their bills.

The Consolidation Study Committee will hold a community listening session on Wednesday, May 9<sup>th</sup>, 6:00 PM at the annex auditorium. I have included the minutes from the last meeting in your notebook.

The Industrial Park infrastructure project is now about 90% percent complete.

We have received a grant for playground equipment at Colson Park from KaBoom! organization for \$15,000 with a local match of \$9,000. We have received an estimate from Georgia Power Company Sports Lighting department for \$115,151.47 to purchase an installed lighting scheme and the same scheme monthly lease amount of \$2,654.35.

Street light at McDuffie and Daniel Streets? Manager Murkerson stated there was a light already there, only put one light at every other pole. He would check with Georgia Power on more efficient lighting.

I have asked City Attorney David Walker to initiate the process of creating a Joint Airport Authority.

Joe English voiced his concerns about the conditions of the Harness Track, that the maintenance was not up to par, the arena was not maintained at all and the festival was so late this year that most of the horsemen had already gone back home. Manager Murkerson told Mr. English that the track and Arena were leased property, but he would talk to them. The City has the prison detail go twice a year to clean and cut the property. The Chamber is looking at changing the festival date to the first weekend in April. Mr. English also reported that he was at the track last week for over an hour and a front end loader was left unattended and was running. Murkerson stated some mechanical work was being done on the equipment, but was not sure why it was left running. He would check in to that and appreciated his concerns.

Dorothy Williams told Commissioner she was pleased to continue to serve on HURA. She reported there were areas in town that looked awful and needed some attention. People are bringing in trash from some where else and putting it on property in the city limits.

Phil NeSmith also mentioned the problem of city dumpsters being filled with county garbage and needed to notify law enforcement to be checking on this problem.
