The ownership percentage will change so all the communities involved will have the same, this gives everybody a bigger percent of revenue. Shelly Berryhill motioned to empower Commissioner Phil NeSmith to authorize the proposed JONG ownership. James Colson seconded, motion passed by yes vote by Chairman Henry Cravey, James Colson, Shelly Berryhill, Ken Hardy and Phil NeSmith. No oppositions or abstains.

APPOINTMENTS TO REGIONAL COMMISSION BOARD: Phil NeSmith motioned to appoint Chairman Henry Cravey as the municipal member and James Colson and Lee Slade as the associate members. Ken Hardy seconded, motion passed by yes vote by Chairman Henry Cravey, James Colson, Shelly Berryhill, Ken Hardy and Phil NeSmith. No oppositions or abstains.

The county will appoint their new Commissioner and then will decide on the non-public voting member with the City Commission input.

SALE OF RIGHT OF WAY ON FIRST STREET BETWEEN JACKSON AND

HOUSTON: Phil NeSmith motioned to approve the sale of 25 feet of right of way on the north side of First Street to Heart of Georgia Gin and Peanut Company. Berryhill asked about the progress on Hartford Water. Murkerson stated still in process, looking for possible grant funds.

Berryhill reported that though the EPD Inert Landfill new regulations proposals are not in force yet, he thanked Murkerson for his input at several meetings before the EPD Board to try and change the ruling.

Phil NeSmith stated they needed to get the city manager performance evaluation done by the end of the year.

NeSmith reported back a few years ago there were talks of the Community Mental Health Center in Hawkinsville would close. He and Henry Cravey had met with the Dublin office and told them the city would help them anyway they could if the Hawkinsville center stayed open. They are now looking at mobile classrooms and possibly moving clients from other areas over here.

Berryhill stated they were still trying to find funding for the Skateboard park. The land next to PHP was donated for the project, but it is a slow process. The Haunted Hospital was a great hit and a plus to the festival.
